UN Review Conference on Small Arms and Light Weapons, New York (26 June–7 July 2006)/  
VN-Überprüfungskonferenz zu illegalem Kleinwaffenhandel, New York (26. Juni – 7. Juli 2006)

The United Nations Review Conference took place at the UN headquarters in New York from 26 June to 7 July 2006. The conference reviewed the progress made over the last five years since the implementation of the UN Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All its Aspects (UN PoA), agreed in 2001, and discussed how to continue the process of small arms control at the international, regional and national level.

On 5 July 2006, BICC organized a side event with SAS launching the book "No Refuge. The Crisis of Refugee Militarization in Africa". The book "No Refuge", published by the Small Arms Survey and BICC, analyses the experience of refugee and IDP militarization in several African countries affected by and emerging from civil war. It provides a considered overview of the historical, political and regional dimensions of refugee and IDP militarization in Africa, as well as international and national efforts to contain it.

Dr. Michael Ashkenazi served as a resource person and trainer for a two-day workshop (22–23 June) at UN Headquarters, New York, for diplomats from weaker states suffering from SALW proliferation. The workshop was organized by UNDDA New York. Representatives of seventeen countries from all continents were present. The training was part of the run up to the Review Conference on the Programme of Action on Small Arms.

From 14–17 June 2006, BICC (with the participation of M. Ashkenazi, E. Isikozlu, W-C. Paes) carried out a localization workshop in Nairobi for training materials on SALW control in Sudan. Present were various Southern Sudan experts and actors, including representatives of UNMIS (United Nations Mission in Sudan), UNDP, and several NGOs. Most significantly, the workshop was attended by the Chair of the Southern Sudan Legislatures Security Committee, a representative of the National Congress in Khartoum, and the Commissioner and Deputy Commissioner of the Southern Sudan DDR Commission.

The workshop concentrated on three main themes: "Organizational parameters and the flow of information and activities on SALW in Southern Sudan", "Potential training locations and audiences" and "The varied experiences of trainers in Southern Sudan".

The most significant result of the workshop was an agreement by BICC to support and work in partnership with the SSDDRC in raising SALW capacity both at the national Southern Sudan level and at the level of all ten states of S. Sudan.

The workshop is part of BICC's SALW capacity building project financed jointly by the German and Canadian governments.
