### I. Transnational migration and security–Price and prejudices

This workshop organized by BICC will take place on Monday, 20 June 2011, 4.00 p.m.

The two aspects security and migration bring together a broad range of issues. Discussions have shown the heterogeneity not only of approaches but also of competing perspectives that have to be taken into account.

- The "securitization" of migration in politics and the media
- EU policy on border security
- The "Security-Migration Nexus" reflected in the media (case studies)
- Implications for policy framing (especially after the changes in the Arab world)

### II. Women–Victims of war

DW and BICC together have organized this workshop, which will take place on Tuesday, 21 June 2011, 11.30 a.m.

Victims of war are seldom seen or heard about in the broader public debate. It is the difficult task of the media to cover the gruesome experiences of women raped during the civil war in the Democratic Republic of Congo, families tyrannized by drug gangs in the favelas of Rio and Mexico, or prisoners of war, tortured and humiliated in conflicts around the world.
